

	How Long: The duration of the detention is negotiated between teacher, parent and principal. Factors include age, likelihood of reflection changing behaviour, individual support needs of the individual and availability of staff to facilitate. Duration is not limited to one session, rather open in duration to achieve behavioural change through restorative practice activities. Duration of any one session will not exceed 20 minutes duration.		
Suspension & Expulsion	When: Only when non suspension measures have been considered and exhausted. When: Individual circumstances suggest that suspension will be effective in managing the behaviour When: A formal caution has been issued in the proceeding 50 school days OR there are immediate and significant health, safety and wellbeing concerns for students or staff that cannot be otherwise mitigated with the student at school. Partnership with parents/carers

Bongongo Public School has partnered with parents/carers in establishing our shared behaviour expectations management strategies. We did this by presenting at P&C meetings, sending information home and providing formal and informal opportunities for feedback prior to implementation. Student were included in the development of our school vision and shared expectations for behaviour.

Bongongo Public School will continue to communicate these expectations to parents/carers through the school website, newsletters, school assemblies and individually during one on one conversations with stakeholders.

Bongongo Public School Anti-Bullying Plan

- **1. Introduction:** Bongongo Public School is committed to providing a safe, inclusive, and respectful learning environment where all students feel valued and supported. This Anti-Bullying Plan outlines our approach to preventing, addressing, and responding to bullying, ensuring student wellbeing remains a top priority.
- **2. Definition of Bullying:** Bullying is repeated verbal, physical, social, or psychological behavior that is harmful and involves an imbalance of power. It can take many forms, including face-to-face, online (cyberbullying), or indirect actions that harm an individual's wellbeing.
- **3. Prevention Strategies:** To foster a positive school culture and prevent bullying, Bongongo Public School will:
 - Implement regular social and emotional learning programs.
 - Promote the school's values of respect, inclusion, and kindness through classroom activities and assemblies.
 - Encourage student leadership through peer support and mentoring programs.



- Provide professional development for staff to identify and address bullying effectively.
- Engage parents and caregivers through communication and educational sessions on bullying prevention.

4. Reporting and Responding to Bullying

- Students are encouraged to report bullying incidents to a trusted teacher, school counsellor, or through anonymous reporting channels.
- Staff will document and investigate all reports of bullying promptly and confidentially.
- Appropriate support will be provided to both the victim and the perpetrator to address underlying issues and promote behavioural change.
- Consequences for bullying behaviour will be aligned with the school's discipline policy

5. Support for Students Affected by Bullying

- Counselling services will be available for students who experience or witness bullying.
- Staff will facilitate mediation and conflict resolution strategies when appropriate.
- Referral to external support agencies will be made if needed.

6. Evaluation and Review

- The Anti-Bullying Plan will be reviewed annually in consultation with students, staff, and parents.
- Data on bullying incidents and responses will be analysed to assess effectiveness and make improvements.
- Feedback from the school community will be used to refine strategies and initiatives.

By implementing this Anti-Bullying Plan, Bongongo Public School remains committed to ensuring a positive and supportive learning environment for all students.
