Secondly, I would like to thank each and every person who has volunteered their time to support the school, the canteen, the uniform shop and the various school events. Without you the P&C couldn't exist!

And thirdly, I would like to personally thank the P&C Executive and Committees members who have done an amazing job despite a virus trying to close us down!

A special thanks to the Executive members Matt Stedman (Vice-President), Aviva Cheng (Vice-President), Angus McDonald (Treasurer), and Kylie Jackson (Secretary).

And to all the committee members, Ria Giann, Walid El Khoury, Ellena Mangavoulakis, Kendal Mackay, Hunter Beanland, Susan Maeng, Heather El-Rahim, Sylvia Anderson, Kate Young, Sharon Brown, Kerrie Hudson, Joanne Giannichronis.

The P&C Canteen run by Eugenie and Dimi (who has left and been replaced by Carmen) exceeded expectations with revenue of just under \$97,000, processing over 20,000 orders, managed a number of menu changes and maintained the highest level of service to our children five days a week.

The Uniform Shop with Ellena's great support had a revenue of \$90,000 and despite all the challenges Covid threw at us provided the best service and affordable clothing for the children.

Last year we spent over \$100,000 on school playground improvements and new technology for the students and school classrooms. This year we are upping our game and spending over \$150,000 on some exciting projects such as:

- Upgrade outdoor learning and play equipment in the Infants Playground
- Renew the synthetic grass in the Primary Playground
- Provide more Interactive White Boards for classrooms
- Supplement the School's renewal of laptops and iPads for teachers and students; and
- Contribute to setting up a full-time STEM room.

So, we look forward to all the school parents and community supporting the P&C in our efforts to make Drummoyne Public School the best possible place to educate our precious children.
